7. Electronic bids must be submitted to the Health Office, Gulmi by electronically through PPMO website <https://www.bolpatra.gov.np/egp/> **on or before 12:00 hours on 8<sup>th</sup> Chaitra 2082 (22<sup>nd</sup> Mar., 2026)**. Bids received after this deadline will be rejected.

8. All bids shall be accompanied by a Bid Security for the amount as specified in the table. Bidders are required to submit a separate bid security for each contract for which they submit bids. The bid security guarantee issued only by the commercial bank approved by Nepal Rastra Bank shall be accepted by the Employer. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, which shall be valid for 30 days beyond the validity period of the bid.
